# **CLASSIFICATIONS OF INFORMATION**

All information, related to an organisation, not considered Secret according to the national law can be considered as information with "limited or forbidden divulgation" or "unclassified". This classification is related to the presence of confidentiality requirements of the information.

In relation to **public information**, one classification level is defined:

• **UNCLASSIFIED**: the internal or external distribution, with reference to the Company, of this kind of information does not create damage for the Defend Consortium and for each partner.

In relation to **private information** three levels of classification are defined, according to the confidentiality requirements:

- INTERNAL USE ONLY: the unauthorized distribution, the loss, the alteration, or undue use of this kind
  of information could create lowest level of 'damage' for the Defend Consortium or for one or more
  partners. The personal data shall be classified as "INTERNAL USE" and managed according to the
  internal consortium procedures established for this classification level, except for those data that are
  classified as "CONFIDENTIAL" or "TOP CONFIDENTIAL"
- **CONFIDENTIAL**: the unauthorized distribution, the loss, the alteration, or undue use of this kind of information could create significant damages for the Defend Consortium or for one or more partners. The **sensitive personal data** shall be classified as "CONFIDENTIAL" and managed according to the internal consortium procedures for this classification level, except for those data that are classified as "TOP CONFIDENTIAL".
- TOP CONFIDENTIAL: the unauthorized distribution, the loss, the alteration, or undue use of this kind of
  information could create extreme damages, in some cases irreversible, for the Defend Consortium
  or for one or more partners.

# 2 Public Presentation

The DEFeND project officially started on the 1<sup>st</sup> of July 2018. The kick off meeting was held in Barcelona on the 18<sup>th</sup> and the 19<sup>th</sup> of July and represented the actual start of project activities.

As the project also foresees an intensive exploitation of social media and ICT for the communication and the dissemination of the project, the public project presentation activities have been delivered according to the following actions:

- Press releases for the communication of the start-up of the DEFeND project;
- Video recorded presentation on the DEFeND YouTube Channel to be disseminated & largely promoted to a broad mailing list;
- Physical events with external key stakeholders.

#### 2.1 PRESS RELEASES

An official press release (see the whole content in the next pages) was disseminated by Atos Spain as Consortium coordinator and by the other Partners involved in the activities. # The DEFeND project started under the patronage of the EU

The project, financed by the European Union under the Horizon 2020 initiative, will deliver a software platform to empower organisations in different sectors to assess and comply to the General Data Protection Regulation (GDPR)

he DEFeND project kicked off at the beginning of July should 2018 and come to completion within 30 months. DEFeND is an Innovation Action (IA) project, and as such its main focus will be improving existing software tools and frameworks and developing new 'integration software', driven by market needs, to deliver unique 8 organizational data privacy governance platform. In particular. the project technical on focus delivering the novel Data Privacy Governance for Supporting GDPR (DEFeND) platform. which supports organizational-focused privacy governance and addresses challenges faced organisations when complying with GDPR.

Organisations, in order to

comply with the GDPR, have to implement in their processes, at a very low-level, different tools, solutions, and processes, so privacy is inherently integrated in these.

Therefore, DEFeND provides a solution that not only supports compliance of the relevant GDPR articles, but also fulfils special characteristics of needs that organisations might have. Although, the market is full of companies offering their services and tools for GDPR compliance, such solutions are mostly focused on providing generic approaches and frameworks that allow organisations to evaluate their current GDPR readiness level and propose some generic guidelines for moving towards

compliance. They do however provide specific methods, techniques and tools tackle the real **GDPR** challenges. It is therefore important to develop tools and methods to assist organisations to implement GDPR and to ensure that such methods and tools focus on solving the challenges that prevent organisations to achieve GDPR compliance but also support continuous compliance.

The DEFeND project targets a range of contributions to achieve the impact of the "DS-08-2017: Cybersecurity PPP: Privacy, Protection, Identities" EU Horizon 2020 call: **Fundamental** -Support for Rights in Digital Society -Increased Trust Confidence in the Digital Single -Increase in the use of privacyby-design principles in ICT systems and services.










These requirements will be addressed through a Privacyby- Design approach that spans over two levels, the Planning Level and the Operational Level, and across three management areas, i.e. Data Scope, Data Process and Data Breach.



## 2.2 VIDEO RECORDED PRESENTATION

The format for the video presentation was chosen in relation to the strong power of image visualisation in order to better understand its contents. The images are accompanied by a voice, which explains the contents of each slide. Subtitles in English and other languages are available in order to increase the project awareness beyond English speaking people and disseminate the project to the wide audience at EU level.

Three videos have already been published on the DEFeND YouTube channel:

- a short project presentation to be spread to a wide audience
- a long project presentation that includes more details and it is also suitable for training purposes
- an Italian project presentation provided by Abi Lab

YouTube was chosen as distribution means as it is known as one of the most used video channels and, thanks to the link between Google and YouTube, the video could be easily found with the provider search engine.

E-mail represents one of the main tools used by private users, companies and Public Administrations to communicate, promote & share information and knowledge with the highest number of people. In order to guarantee a fast and wide spread of the recorded video, it has been decided to follow an intense mailing strategy to the partners' contacts.

Some of the partners created also a direct link to the DEFeND website in order to increase the visibility and maximize the impact of the initiative starting from their respective homepages.

The DEFeND Platform addresses two different kinds of users. The first category of users is represented by the potential customers (e.g. end user categories like Public Administration, Healthcare, Energy and Banking organizations), the second type of users refer to citizens and common public. However, the DEFeND project addresses many European countries and not all customers and citizens are used to manage material in English. With the inclusion of the subtitles in English and in other national languages the Consortium aims to extend the communication to the EU public at large extent.

### 2.3 EVENTS

### 4 Conclusions

The DEFeND project was adequately communicated and disseminated during the first year through virtual channels (website, social media) and several physical events.
